TERMS & CONDITIONS:

1. The school shall follow the course of study as per syllabus-prescribed by the affiliated board.
2. The school shall charge fees and funds as declared to the appropriate authority at the time of application for recognition and display the same on the notice board of the school and shall not increase the fees during any academic session. In case of change in the fee structure the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed receipt of fees/funds to the students.
3. Salary shall be paid as per declaration at the time of seeking recognition.
4. No capitation fee and other charges shall be changed from the children/parents.
5. School shall be open for admission without any discrimination based on religion, caste, race, place of birth of any other whimsical.
6. Managing committee shall not allow to run two school affiliated by different board/council in the same premises.
7. Managing committee shall not close down the school or an existing class during the academic session without the prior approval of the appropriate authority.
8. The school shall open for inspection for the inspecting officer authorized by the Director/Appropriate Authority.
9. Recognition so granted shall be reviewed after every 10 years.
10. No financial assistance shall be granted by the department of the school.
11. School premises shall not be used for commercial purpose and anti National Activities.
12. Approval of Managing Committee shall be obtained from the appropriate authority in case of any change in the committee.
13. The managing committee shall follow the instructions issued by the Government/Director from time to time and supply the information to the Govt./Department as required.
14. In addition to above the Managing Committee shall abide by the provisions of Haryana School Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action in case of violation of any provisions of the rules.




